**(ENTRANCE EXAMINATION FOR SELECTION OF CANDIDATES FOR ADMISSION INTO
M.Sc. NURSING COURSES IN THE COLLEGES OF ASSAM FOR THE SESSION 2025)**

Applications are invited from eligible candidates intending to undergo M.Sc. Nursing Courses in the Colleges of Assam for the session 2025 in prescribed form, to be obtained from the Office of the Principal, Regional College of Nursing, Guwahati from **02.05.2025** during office hours on deposition of **Rs. 1000/- (Rupees one thousand) only** in the form of Demand Draft/Banker's Cheque drawn in favour of "**Srimanta Sankaradeva University of Health Sciences**" payable at "**SBI, GMC Branch, Guwahati**". The last date of submission of filled in Application Form at the Office of the Principal, Regional College of Nursing, Guwahati is **31-05-2025**.

A non-refundable examination fee of **Rs. 5000/- (Rupees Five Thousand) only** is required to be paid in online mode only through the Payment Gateway available in SSUHS website. (www.ssuhs.in >Fee Collect >Student Category >Entrance Exam Fee >Name of Exam >Course-M.Sc.Nursing). This examination fee is exempted for PwD (Divyang) category of candidates.

The Entrance Examination is going to be held on **29-06-2025 (Sunday) at Guwahati from 10.00 AM to 1.00 PM**. The Entrance Examination shall consist of 100 (one hundred) Multiple Choice Questions from the syllabus of B.Sc. Nursing Course. There shall be no negative marking.

Applicants or their duly authorized persons will have to collect the Admit Cards from the Office of the Principal, Regional College of Nursing, Guwahati from **16-06-2025** onwards during office hours.


The eligibility criteria for M.Sc. Nursing course are as follows:

1. Candidates who passed B.Sc. Nursing degree or equivalent from Nursing Colleges recognized by Indian Nursing Council.
2. Must be a citizen of India.
3. Must be a Permanent Resident of Assam for admission in Govt. Colleges of Assam. This will not be applicable for Son/Daughter/ Husband/ Wife of employee of the Govt. of Assam.
4. Must have R.N/R.M or equivalent certificate with State Nursing Council.
5. Must have a minimum of 1 (one) year of work experience after Basic B.Sc. Nursing or minimum one year of work experience prior to or after Post Basic B.Sc. Nursing.

6. Must have secured minimum 55% aggregate marks in B.Sc. Nursing/B.Sc. Hons. Nursing/ Post Basic Nursing and there will be 5% relaxation of marks for SC/ST candidates.
7. In case of NEC candidates, the Permanent Resident Certificate of Assam will not be required. The application form must be forwarded by the Secretary/ Authorized representative of NEC and should also authenticate the caste of the candidate. They will also be required to appear in the Entrance Examination.
8. Reservation of seats in Govt. Colleges of Assam will be as per Assam Govt. Rule.

The distribution and reservation of seats including admission shall be notified by Directorate of Medical Education, Assam in due course of time.
